The National Joint Council for Local Government Services have agreed a pay increase to be effective immediately, and backdated to April 2024. The Clerk has not had a pay increase since starting in September 2016. A cheque will be signed at the January meeting for the backdated pay at the original pay rate, and a letter to Lloyds Bank to reflect the increase in hourly rate. It was agreed to move the Clerk to SCP 17, and increase hours by 3 to 20 per month. It was agreed to pay 40 hours overtime out of 60 accrued to the end of October, again at the original pay rate.
